**REQUEST FOR QUOTATION FOR  
CONSTRUCTION OF SMALL WATER IMPOUNDING SYSTEM (SWIS) SPRING  
DEVELOPMENT PROJECT – LOT XI CONSTRUCTION OF SPRING BOX AND  
STORAGE TANK AT AMOMOKPOK, RAGAY, CAMARINES SUR (12 CU.M)**


1. The *Provincial Environment and Natural Resources Office of Camarines Sur*, through the *General Appropriations Act (GAA)*, intends to apply the sum of ***Eight Hundred Seventy-Nine Thousand Pesos Only (Php 879,000.00)*** being the Approved Budget for the Contract (ABC) to payment under the contract for the ***Construction of Small Water Impounding System (SWIS) Spring Development Project – Lot XI Construction of Spring Box and Storage Tank at Amomokpok, Ragay, Camarines Sur (12 cu.m)*** with Identification Number ***PCS-SWIS-2023-011***.
2. The procurement of the project is in line with the issuance of Sub-Allotment Advice (SAA) No. SR2023-02-000001 dated February 9, 2023 to cover funding requirements intended for the construction of Small Water Impounding System for CY 2023. Said Sub-Allotment Advice shall form part of the bidding documents of this procurement activity.
3. The *Provincial Environment and Natural Resources Office of Camarines Sur* now invites bids for the above Procurement Project. Completion of the project is required within the expected project duration of sixty (60) days based on the Approved Terms of Reference. Bids received in excess of the ABC shall be automatically rejected at bid opening.
4. Interested bidders may obtain further information from *Provincial Environment and Natural Resources Office of Camarines Sur* at the address given below during office hours, 8:00 AM to 5:00 PM.
5. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before ***March 16, 2023 at 9:00 AM, except weekends and holidays***. Late bids shall not be accepted.
6. Bidders shall submit the accomplished Request for Quotation in a sealed envelope together with the ff. documents:
  1. Valid and Current Mayor's/Business Permit
  2. Platinum PhilGEPS Registration
  3. BIR Registration
  4. Updated Income/Business Tax Return
  5. Philippine Contractors Accreditation Board (PCAB) License
  6. Notarized Omnibus Sworn Statement

**Updated BIR Tax Clearance** issued by the BIR C.O shall be required from winning supplier/service provider before the award of Contract. Non-submission of this document on the deadline set shall be construed as waiver, hence award shall be given to the supplier who offered the next lowest quotation, provided accreditation requirement is met.


