INVITATION TO BID FOR LOT II – ESTABLISHMENT OF 143 HA. BAMBOO PLANTATION

1. The *Provincial Environment and Natural Resources Office of Camarines Sur*, through the *Sub-Allotment Advice* intends to apply the sum of **One Million Two Hundred Sixteen Thousand Seven Hundred Ninety-Two Pesos (Php 1,216,792.00)** being the ABC to payments under the contract for *Lot II* with identification number **PR No. 142-10-2020 dated October 28, 2020**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Provincial Environment and Natural Resources Office of Camarines Sur* now invites bids for the above Procurement Project. **The duration of the Project is two (2) months**. Bidders should have completed, within **five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from *Provincial Environment and Natural Resources Office of Camarines Sur* and inspect the Bidding Documents at the address given below during office hours, **8:00 AM to 5:00 PM**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **November 26, 2020 to December 15, 2020** from the given address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php 5,000.00)*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person, by facsimile, or through electronic means*.
6. The *Provincial Environment and Natural Resources Office of Camarines Sur* will hold a Pre-Bid Conference on **December 4, 2020, 2:00 PM** at *PENRO Conference Room, Panganiban Drive, Naga City, Camarines Sur* and/or through video


conferencing or webcasting *via Zoom Application*, which shall be opened to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before *December 16, 2020, 8:30 AM*. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
9. Bid opening shall be on *December 16, 2020 9:00AM* at the given address below and/or *via Zoom Application*. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The *Provincial Environment and Natural Resources Office of Camarines Sur* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.

TERMS OF REFERENCE

ESTABLISHMENT OF 143 HA. BAMBOO PLANTATION

- A. The Establishment of 143 ha. Bamboo Plantation under the Forest and Watershed Management: Enhanced National Greening Program shall be bid out to DENR V Accredited Peoples Organization (POs), Civil Society Organizations (CSOs), or Non-Government Organizations (NGOs) pursuant to Republic Act No. 9184, otherwise known as the Government Procurement Reform Act. However, projects with Approved Budget Cost (ABC) in the amount not exceeding One Million Pesos (<Php 1,000,000.00) must be under Negotiated Procurement thru Small Value Method. On the other hand, projects with ABC above One Million Pesos (>Php 1,000,000.00) shall strictly follow public bidding under the said Act.

- B. Project Duration : Two (2) months
C. Location and Area : AOR of CENRO Sipocot/143 ha.
D. Species/Commodity : Bamboo
E. ABC : Php 1,216,792.00
F. Scope of Work

F.1. Site Preparation and Planting

- F.1.1. Strip or Circular brushing/Cultivation
- F.1.2. Hole digging
- F.1.3. Planting and staking.

F.2. Protection and Maintenance

- F.2.1. Strip or Circular brushing/Cultivation
- F.2.2. Fertilizer application
- F.2.3. Establishment of Fireline, if applicable (width and length will depend on the condition of the area)
- F.2.4. Patrol works
- F.2.5. Replanting

EXECUTION OF WORK

- a. Upon approval of the Contract and Issuance of Notice to Proceed, the stakeholder/partner implementer shall immediately commence the activities indicated in the approved Work and Financial Plan (WFP), Contract Agreement, and Terms of Conditions (TOR) in coordination with the DENR-P/CENR Office for proper supervision and monitoring of the project.
- b. Regular monitoring of the project activities shall be conducted by the technical personnel of the DENR to ensure that all activities are performed in accordance with the approved specifications.
- c. The Stakeholder/Partner Implementer shall maintain records of all activities being performed and be made available at all times to the DENR staff. Any occurrence of force majeure e.g typhoon, wildfire/forest fire, and other factors affecting the implementation of the project must be reported to the implementing DENR unit within 5 days after its occurrence.

- d. DENR Composite Inspection and Monitoring Team shall conduct inspection of the accomplished activities based on the approved specifications and shall recommend payment corresponding to the actual accomplishment.


PAYMENT OF CONTRACT PRICE

Payment of contract price to the Stakeholder/Partner Implementer is based on the actual activities accomplished (progress billing) as validated by the Composite Inspection and Monitoring Team. A 10% from every billing shall be deducted for the retention fee which will only be released to the partner implementer after the project is turned-over and accepted by the DENR.

PENALTY

The DENR shall charge the Stakeholder/Partner Implementer with liquidated damages in the amount equivalent to one tenth (1/10) of one percent (1%) of the cost of the unperformed portion for every day of delay. Once the cumulative liquidated damages reach ten percent (10%) of the amount of the contract, the DENR shall rescind the contract, without prejudice to the courses of action and remedies open to it.
